ELIGIBILITY:

Artwork must be original, current, and not previously exhibited in this Festival or in Monmouth County in the six months prior to the Festival.

JURYING:

All works exhibited in the 2010 Festival will be juried either in person or on CD. Artists agree to exhibit the pieces accepted by the juror.

PAINTING, PHOTOGRAPHY, MIXED MEDIA: No less than 3, no more than 6 pieces for jurying. Any single hanging piece exceeding 25 square feet constitutes two submissions.

SCULPTURE: Maximum of 6 pieces for jurying.

CERAMICS, WOOD, PAPER, FIBER, GLASS, METAL, JEWELRY: Maximum of 6 pieces for jurying.

NO Offset lithographs, reproductions, or giclee for jurying.

IN-PERSON SUBMISSIONS:

For all **PAINTING, PHOTOGRAPHY AND HANGING MIXED MEDIA:** exhibited work must be framed, ready for hanging & for sale. Attach a label with title & price in the lower, right corner of framed pieces. (Portfolio pieces by accepted artists will be included in the Festival but will not be juried.)

For all **SCULPTURE, CERAMICS, WOOD, FIBER, GLASS, OR METAL:** attach a label with title and price to the back or the bottom of the work.

For **JEWELRY:** attach a tag with the price and materials used. (Include all this information when completing the entry form.)

DIGITAL SUBMISSIONS:

JPEGS at 300 dpi **only** labeled with your name and title of artwork. *All Fine Arts please specify size of pieces for jurying. CDs will not be returned.

JURY DAY PROCEDURES:

- December notification of Jury date & time (via e-mail, if available).
- Bring artwork 15 minutes prior to assigned jury time to Monmouth Reform Temple, 332 Hance Avenue, Tinton Falls, NJ
- Anticipate an hour jury time.
- Plan to take your work home after jurying.
- January notification of results will be sent (via e-mail, if available).
